



## OFS Capital Corporation Commences Offering of Notes

October 21, 2021

CHICAGO--(BUSINESS WIRE)--Oct. 21, 2021-- OFS Capital Corporation (the "Company") (Nasdaq: OFS) announced today that it has commenced an underwritten offering of unsecured notes (the "Notes"), subject to market and other conditions. The Company has submitted an application for the Notes to be listed and trade on The Nasdaq Global Select Market under the trading symbol "OFSSH". If approved for listing, the Company expects the Notes to begin trading within 30 days from the original issue date. The interest rate and other terms of the Notes will be determined at the time of pricing of the offering.

The Company intends to use the net proceeds from this offering to fully or partially pay down, retire, or redeem certain of its outstanding indebtedness, which may include the Company's 6.25% Notes due 2023, 5.95% Notes due 2026 and/or borrowings under its secured revolving credit facility with BNP Paribas (the "BNP Facility"). As of October 19, 2021, the Company had approximately \$25.0 million aggregate principal amount outstanding, plus accrued interest, of 6.25% Notes due 2023, which mature on September 30, 2023, and bear interest at a rate of 6.25% per annum. The Company's 6.25% Notes due 2023 will be redeemed on November 1, 2021. As of October 19, 2021, the Company had approximately \$54.3 million aggregate principal amount outstanding, plus accrued interest, of 5.95% Notes due 2026, which mature on October 31, 2026, and bear interest at a rate of 5.95% per annum. As of October 19, 2021, the Company had \$78.1 million of indebtedness outstanding under the BNP Facility, which bore interest at rates from 1.84% to 2.60% as of such date. The BNP Facility matures on June 20, 2024.

Ladenburg Thalmann & Co. Inc. and Goldman Sachs & Co. LLC are acting as joint lead book-running managers of this offering. B. Riley Securities, Inc. and Oppenheimer & Co. Inc. are acting as joint book-running managers of this offering.
