#### Item 5.07 Submission of Matters to a Vote of Security Holders.

On June 4, 2019, OFS Capital Corporation, a Delaware corporation (the "Company"), held its 2019 Annual Meeting of Stockholders (the "Annual Meeting"). There were present at the Annual Meeting in person or by proxy stockholders holding an aggregate of 11,447,413 shares of the Company's common stock, out of a total number of 13,361,134 shares of the Company's common stock issued and outstanding and entitled to vote at the Annual Meeting. The following matters were submitted at the Annual Meeting to the Company's stockholders for consideration:

- 1. The election of a Class I director who will serve for three years, or until her successor is elected and qualified; and
- 2. The ratification of the selection by the Audit Committee of the Company's Board of Directors of KPMG LLP as the Company's independent registered public accounting firm for the fiscal year ending December 31, 2019.

Elaine E. Healy was elected to serve as Class I Director until the 2022 annual meeting of stockholders, or until her successor is elected and qualified, and the appointment of KPMG LLP as the independent registered public accounting firm for the Company for the fiscal year ending December 31, 2019 was ratified.
